Summary of COVID-19 Response & Outreach Activities (March-June 2020):

SINFPA's Staten Island COAD & its Medical Ecosystem (MES) subcommittee have been activated in the COVID-19 response on Staten Island, acting as an emergency operations center working in partnership with the Staten Island Borough President's Office, local elected officials, healthcare organizations, social service providers and response agencies:

- An Incident Command System (ICS) taskforce comprising representatives from both Island
 hospitals Richmond University Medical Center and Northwell/Staten Island University Hospital
 (chief medical officers and emergency preparedness staff), the medical society/primary care
 physicians, the Island's 11 skilled nursing facilities, nonprofit and community-based
 organizations, and the office of the Borough President, met daily to discuss challenges and
 response and to advocate on behalf of Staten Island to the city and state.
- Via the MES provided communications, resources and addressed institutional and community-wide needs around supplies, staffing and surge space, patient flow, and care protocols.
- SINFPA/COAD shared guidance on mandates, resources, funding, and relief opportunities for nonprofits.
- Steering committee comprised of representatives of the SINFPA Board, MES, community-based
 organizations and SI Long Term Recovery Organization met weekly to share information, needs,
 observations, and brainstorm action plans to serve the needs of our local nonprofits. Have been
 partnering on assessment, outreach, and response.
- In partnership with Office of the BP, secured donations of supplies and launched fundraising campaign to purchase supplies for frontline providers. Created a COVID-19 Response & Supplies Fund and crafted policies, processes, and procedures to procure and distribute secured supplies. Raised nearly \$30k from 360+ donors to our COVID-19 Supplies Fund, including support from The Staten Island Foundation, community members and elected officials.
- Advocacy & partnerships with NYC DOHMH New York City Health Care Coalition (NYCHCC) / SI Borough Coalition Lead (funding via NYC DOHMH Hospital Readiness & Healthcare Coalitions/ASPR); NYCEM Community Preparedness Council; NYC DOHMH Community Resilience Planning Committee; NYC DOHMH Emergency Partner Engagement Coalition (EPEC); NYC Voluntary Organizations Active in Disaster (VOAD) Citywide Coalition of COADs/Emergency Networks; Nonprofit New York; Human Services Council of New York; NYC Rapid Response Coalition/Public Health Solutions, NYC COVID-19 T2 Testing & Tracing Community Advisory Board; and others.
